

## **Participant Registration Regulations**

### **§1. General Provisions**

1. These regulations ('Regulations') set out the rules for registration and participation in the ***INTERNATIONAL CTEPH CONFERENCE 2026***('Conference'), which will take place ***11 – 13 June 2026, Warsaw, Poland***.
2. The organiser of the Conference is Promotion Plus Elżbieta Multan-Putur, 05-510 Chylice, ul. Pogodna 18, NIP 525 199 65 48, REGON 014999033.
3. The provisions of the Regulations constitute an integral part of the Conference Participation Application and are binding on all Conference participants.
4. The Conference participants are: (a) persons authorised to issue prescriptions and persons trading in medicinal products within the meaning of Article 52(2)(6) of the Act of 6 September 2001  
Pharmaceutical law, in particular cardiologists, internists, doctors of other specialties, primary care physicians, lecturers who are authorised to issue prescriptions (b) other persons professionally related to the subject matter of the Conference; (c) lecturers who are not authorised to issue prescriptions.
5. The Conference will include scientific and educational sessions and a virtual exhibition of the medical and pharmaceutical industry intended exclusively for Conference participants referred to in point 1.4(a) of the Regulations.

### **§2. Rules of participation and cancellation of participation**

1. The conditions for participation in the Conference are as follows:
2. Registration via the registration form available on the Conference website [www.cteph2026.org](http://www.cteph2026.org)
3. Payment of the fee in the amount and within the deadline specified by the Organiser.
4. Conference participants may choose the following forms of payment for the registration fee:
  - a. traditional bank transfer to the Executive Organiser's account: 03 1140 2004 0000 3702 8235 2513 conference participation fee, specifying:
  - b. in the case of an individual fee (confirmed by a personal VAT invoice): first and last name, address,
  - c. in the case of a business activity (e.g. a doctor's office): name, address, tax identification number,

d. in the case of registration paid for by a company (third party): full company name, address, tax identification number and first and last name of the person for whom the fee is being paid.

e. bank transfer or payment card via the external payment system przelewy24.pl, operated by PayPro S.A. based in Poznań.

f. Bank transfer or payment card via the external payment system PayNow, operated by mElements S.A. based in Warsaw.

6. The Executive Organiser will issue an invoice for the payments made.

7. The invoice will be sent by e-mail in PDF format to the e-mail address provided during registration.

8. A participant who will give a presentation on a given topic is a person who:

a. participates in a scientific and educational session and workshop with their own presentation,

b. has been qualified by the Scientific Committee of the Conference and will be informed of this fact by e-mail.

9. Participants presenting an abstract or clinical case are not exempt from the registration fee.

10. THE FOLLOWING ARE EXEMPT FROM CONFERENCE PARTICIPATION FEES: lecturers, session chairs, full-time medical students. Persons exempt from conference participation fees shall submit a statement to this effect by indicating their status on the registration form, for which they shall be responsible in accordance with the provisions of § 5 of the Regulations.

11. Participants referred to in § 1(1.4)(b) and (c) of the Regulations are not entitled to participate in scientific and educational sessions or the exhibition of medical and pharmaceutical companies.

12. The participant referred to in § 1(1.4)(a) of the Regulations shall receive confirmation of participation in the Conference in PDF format from the Executive Organiser to the e-mail address provided during registration, after the end of the conference proceedings.

13. For participation in the Conference, the Conference participant referred to in § 1 section 1.4 point a) of the Regulations will receive educational points in accordance with the rules established by the Medical Chamber.

14. The cost of participation in the Conference shall be covered by the participant, subject to the services included in the registration fee.

15. The Executive Organiser has the right to refuse a participant's participation in the Conference if they have not paid the Conference participation fees within the deadlines set by the Organiser (details on the Conference website subpage in the 'Registration' section).

16. The deadline for submitting applications to participate in the Conference via the website is 11 June 2026. In the case of in-person participation in the Conference, participants acknowledge the restrictions on participation in gatherings and conferences introduced by the Regulation of the Council of Ministers of 6 May 2021 on the establishment of certain restrictions, orders and prohibitions in connection with the state of epidemic (Journal of Laws 2021, item 861) <https://www.gov.pl/web/koronawirus>.
17. The participant may withdraw from participation in the Conference. The participant's withdrawal from participation in the Conference should be made in writing. In the event of a participant's withdrawal from participation in the Conference:
  - a. if the Executive Organiser receives a statement of withdrawal from a Participant who is not a consumer earlier than 30 days before the start of the Conference, the Executive Organiser shall refund the amount paid by the Participant, less administrative costs amounting to 25% of the total fee, provided that the payment for participation has been received in advance.
  - b. if the Executive Organiser receives a statement of resignation from a participant who is not a consumer on the 30th day before the start of the Conference or later, the Executive Organiser has the right to retain the entire payment received.
  - c. After the Participant has completed all formalities, including returning the signed correction to the Executive Organiser's address, the Executive Organiser has 90 days to refund the funds.
18. The Organiser reserves the right to change the speakers at the Conference without giving any reason. In such a case, the Conference Participant shall not be entitled to compensation from the Organiser or the Executive Organiser.
19. Conference participants are obliged to participate in the Conference in a manner that does not hinder or disrupt the Conference and not to take any actions that are contrary to generally applicable law or good manners, or that violate the personal rights of other participants or the legitimate interests of the Organiser, the Executive Organiser or other Conference participants.

### **§3. Prices and terms of payment**

1. The prices and terms of payment for participation in the Conference are available on the Conference website at [www.cteph2026.org](http://www.cteph2026.org)

2. The payer (invoice recipient) is the entity ordering individual services related to participation in the Conference. Once the invoice has been issued, changes will only be possible in special cases.
3. Failure to pay the fee for participation in the Conference within the deadline specified on the conference website entitles the Executive Organiser to cancel the registration without incurring any liability for damages.

#### **§4. Liability**

1. The Executive Organiser and the Organiser shall not be liable for:
  - a. incorrect data entered by the Conference participant, failure to meet the technical requirements referred to in § 4 of the regulations necessary to participate in the Conference remotely,
  - b. damages incurred and lost profits by the Participant, which were caused as a result of: false data provided by the person registering, actions or omissions of third parties over which the Executive Organiser and the Organiser had no control, changes to the duration, shortening or cancellation of the Conference due to circumstances for which the Executive Organiser and the Organiser are not responsible.
  - c. the manner in which the Participant uses the knowledge and skills acquired during the Conference.
2. Conference Participants use the substantive content resources available at [www.cteph2026.org](http://www.cteph2026.org) at their own risk and on their own responsibility.

#### **§5. Complaints**

1. Any complaints by Conference participants against the Organiser or the Executive Organiser should be submitted in writing by registered letter with acknowledgement of receipt to the address of the Executive Organiser's registered office, i.e. ul. 2. Complaints by Conference participants may be submitted no later than 3 days after the end of the Conference.
3. After the above-mentioned deadlines, no complaints will be considered.
