

## Participant Registration and E-Commerce Regulations

### §1. General Provisions

These Regulations (“Regulations”) define the rules for participation in the **INTERNATIONAL CTEPH CONFERENCE 2026** (“Conference”), which will take place on **11–13 June 2026 in Warsaw, Poland**, and the terms of use for the associated online platform.

All provisions of these Regulations are binding on Conference participants and users of the online platform.

#### 1.1 Conference Participants

Participants include:

- (a) authorized medical practitioners, including cardiologists, internists, other specialists, primary care physicians, and lecturers authorized to issue prescriptions;
- (b) other persons professionally related to the subject matter of the Conference;
- (c) lecturers not authorized to issue prescriptions.

Scientific and educational sessions, as well as a virtual exhibition of the medical and pharmaceutical industry, are intended exclusively for participants referred to in point (a).

#### 6. Withdrawal and Cancellation

Participants may withdraw in writing:

- 30 days before Conference: refund minus 25% administrative costs.
- ≤30 days before Conference: no refund.

Participants must act in a manner that does not disrupt the Conference or violate the law, rights of other participants, or legitimate interests of the Organiser.

#### 8. Changes in Speakers

The Organiser may change speakers without liability to participants.
